## **Relational Psychodynamic Psychotherapist (PhD, PsyD, LICSW or LMHC)**

Clinical Alliance Services, LLC is a group practice serving the Cambridge and greater Boston communities. We offer individual, couples and group therapy to adults of all ages. Our treatment model is heavily influenced by culturally informed relational psychodynamic and attachment-based treatment approaches, although our clinical team is trained in a variety of other treatment approaches. We value the flexibility to deliver integrative treatment approaches to best meet our clients' needs. We are committed to offering mental health services in an inclusive setting, anchored in a social justice framework, and are passionate about providing services to clients across all identities, experiences and backgrounds.

We are hiring a full-time or part-time Relational Psychodynamic Psychotherapist / Staff Clinician:

### Candidate requirements:

- PhD, PsyD, LICSW or LMHC and independent licensure in Massachusetts;
- 3+ years of experience providing psychodynamic psychotherapy in adult outpatient settings;
- Demonstrated cultural competence and cultural humility; and
- Experience working with clients across diverse identities.

### Responsibilities:

- Provide weekly or twice-weekly in-person or telehealth psychotherapy sessions;
- Attend weekly group clinical consultation meetings;
- Complete clinical documentation, including initial evaluations, progress notes and termination summaries, in a timely manner; and
- Attend meetings with Executive Director and Clinical Director.

### Full-Time position schedule:

- Min. 26 billed sessions/week, requiring availability to schedule up to 30 sessions/week;
- Approximately 4 to 5 hours/week of clinical documentation;
- 1.5 hours/week clinical consultation meeting; and
- Monthly meetings with Clinical Director and Executive Director.

### Part-Time position schedule:

- Option 1: Min. 20 billed sessions/week, requiring availability to schedule up to 24 sessions/week;
- Option 2: Min. 16 billed sessions/week, requiring availability to schedule up to 20 sessions/week;
- Approximately 2 to 4 hours/week of clinical documentation;
- 1.5 hours/week clinical consultation meeting; and
- Monthly individual meetings with Clinical Director and Executive Director.

Psychotherapists set their own in-office (based on office availability) and telehealth schedules. No on-call hours are required. All employees begin to accrue four weeks of annual paid time off (PTO) as of their start date and become eligible for 401K with employer match available after 12 months and 1,000 hours of employment. Full-time employees are eligible for health, dental and vision insurance.
