## **Postgraduate Mental Health Counseling Fellowship**

Clinical Alliance Services, LLC offers a two-year Postgraduate Mental Health Counseling Fellowship for Mental Health Counselors interested in expanding their clinical training in relational psychodynamic and attachment-based psychotherapy approaches. The Fellowship trains mental health counselors in culturally informed, relational psychodynamic treatment approaches. Fellows will learn the basic tenets of relational psychodynamic psychotherapy, including the use of self and relationship to facilitate change in psychotherapy. In collaboration with their supervisors and peers, Fellows will learn to actively reflect on the therapeutic process and their role in it, in service of utilizing interventions and developing clinical formulations, as well as tailoring treatment plans for their clients. Fellows will also be encouraged to critically reflect on the impact of their personal identities and experiences, and the broader systems in which these exist, on their clinical work.

### **Training Goals**

Fellows will learn to recognize and understand the:

- influence of the unconscious on their and others' behavior;
- impact of early experience on later development;
- how the current therapeutic relationship is influenced by clients' early relationships;
- benefits and limitations of psychodynamic treatment approaches and when alternative treatment approaches, including specialty treatment or higher levels of care, may be clinically indicated; and
- experience of difference and the impact of oppression on their own lives and the lives of clients, including the ability to reflect on the internal unconscious meanings of these experiences and their impact on both the therapeutic relationship and process.

### **Training Opportunities & Responsibilities**

Fellows are responsible for scheduling up to 26 psychotherapy sessions per week, resulting in an average of 20 to 22 billable sessions per week, with clients participating in weekly or twice weekly psychotherapy. Fellows receive two hours of weekly individual clinical supervision and 1.5 hours of group clinical supervision with experienced staff clinicians and attend a weekly Psychodynamic Theory & Practice Seminar alongside Postgraduate Social Work Fellows and Predoctoral Psychology Fellows. Trainees are required to work five days per week providing both in-person and telehealth psychotherapy services and must be on-site in our Cambridge office two days per week.

## **Sample Schedule**

- Psychotherapy: Availability to schedule up to 26 sessions per week, resulting in an average of 20 to 22 billable sessions per week
- Clinical Documentation: Approximately 3.5 hours per week
- Individual Clinical Supervision: 2 hours per week
- Group Clinical Supervision: 1.5 hours per week
- Psychodynamic Theory & Practice Seminar: 1 hour per week
- BIPOC Clinicians Seminar & Consultation Group or White Clinicians Allyship & Accountability Seminar: 1.5 hours per week
- Meetings with Director(s): 1 to 2 hour(s) per month

## **Pay & Benefits**

\$40 per hour as a W-2 employee for psychotherapy, clinical documentation, supervision, seminar, case conference and other required meetings. Full-time benefits include health and dental insurance, in addition to four weeks of accrued Paid Time Off (PTO). Fellows become eligible for 401K with employer match after one year of employment.

## **Applicant Requirements**

Fellowship applicants must meet the following requirements:

1. Attain an M.A. or M.S. in Mental Health Counseling from a graduate program meeting the Education Requirements of the Board of Allied Mental Health and Human Services Professions for licensure as a Mental Health Counselor by the Fellowship start date;
2. Meet all Pre-Master's Degree Experience Requirements of the Board of Allied Mental Health and Human Services Professions for licensure as a Mental Health Counselor; and
3. Have completed a formal internship / externship in outpatient adult psychotherapy and/or college counseling.

## **Application Instructions**

4. an official or unofficial copy of graduate transcript.

**Application Deadline:** Application will be accepted starting January 1st with an application deadline of March 1st. Interviews will be scheduled and offers will be presented on a rolling basis, so it is possible that all positions will be filled prior to March 1st.

**Start Date:** The Postgraduate Mental Health Counseling Fellowship starts the week of August 24, 2026 with a required orientation and initial supervision meetings, full programming starts on September 1st, and the Fellowship terminates on August 31, 2028.
